WHEREAS, the Department of Education-Kidapawan City Division Bids and Awards Committee, through the School Health Unit, is mandated to implement a divisionwide School-Based Feeding Program (SBFP) pursuant to Republic Act No. 11037 also known as the *"Masustansyang Pagkain para sa Batang Pilipino Act"*, and the General Appropriations Act (GAA) for the Fiscal Years 2019-2020;

WHEREAS, R.A. No. 11037 provides the inclusion of fresh milk or fresh milk-based products in the SBFP as additional component to hot meals;

WHEREAS, the DepEd and the National Dairy Authority (NDA) / Philippine Carabao Center (PCC) have agreed to embark on and implement a Milk Feeding Program pursuant to the mandates and objectives of R.A. No. 11037 and as a component of the National Feeding Program of the government;

WHEREAS, pursuant to DepEd Order No. 036, s. 2019, Guidelines on the Implementation of School-Based Feeding Program-Milk Feeding Program Component and all subsequent issuances relative thereto, SDOs shall have the responsibility of coordinating and directly dealing with the relevant island offices of the NDA, headquarters, genepool and regional centers of the PCC or any other relevant field offices of government and non-government unit or organization, as well as with the local dairy farms and/or cooperatives;

WHEREAS, the DepEd entered into a separate Framework Memorandum of Agreement (framework MOA) with NDA and PCC to govern their collaborative undertaking, define the policy and general framework of cooperation and coordination between the said parties, as well as the operational details in the implementation of the Program; copy of the framework MOA is attached and marked as Annex "A";

WHEREAS, pursuant to the aforementioned law, the DepEd Order and the framework MOA, DepEd shall source its fresh pasteurized and/or sterilized milk supplies from local dairy farms and/or dairy cooperatives indicated in the approved source/supply map; copy of the source/supply map is attached and marked as Annex "B";

WHEREAS, based on the source / supply map, the SDO is in need of pasteurized and/or sterilized fresh milk for the School-Based Feeding Program – Milk Component for all Kinder learners and identified Grade 1 to Grade 6 beneficiaries within its jurisdiction, with an estimated budget of **Philippine Pesos One Million Two Hundred Sixty Five Thousand Three Hundred Seventy One and 20/100 only (Php1,265,371.20)**, detailed as follows:

WHEREAS, Negotiated Procurement by Agency-to-Agency Agreement, under Section 53 of the same IRR, is an alternative method of procurement under which procurement may be made from another agency of the government that has the mandate to deliver goods or services or to undertake infrastructure projects or consultancy services as required by the Procuring Entity;

WHEREAS, the Bids and Awards Committee (BAC) is tasked to recommend to the Head of Procuring Entity the use of alternative modes of procurement when the conditions required by law for the use of alternative modes are present to promote economy and efficiency;

WHEREAS, the BAC, in the conduct of the procurement activity for the subject project, takes notice of the Framework Memorandum of Agreement entered into by DepEd and NDA/PCC, and has undertaken due diligence and exerted best efforts to ensure faithful compliance with the provisions of RA 9184, its implementing rules and regulations, and relevant laws and issuances;

WHEREFORE, all premises considered, the Bids and Awards Committee resolved to recommend to the Head of Procuring Entity, the use of Negotiated Procurement-Agency-to-Agency described herein in accordance with the provisions of R.A. 9184 and its Implementing Rules and Regulations to procure above-described goods and other ancillary services bundled to this project in the total amount of **Philippine Pesos One Million Two Hundred Sixty Five Thousand Three Hundred Seventy One and 20/100 only (PhP1,265,371.20)**, to wit:


