Approving the Procurement for the Supply and Delivery of Supplies for the Reproduction of MHPSS and Self-Learning Modules for Earthquake Affected Learners in Kidapawan City as part of Education in Emergency in the New Normal brought about by Covid-19 Pandemic under Negotiated Procurement - Emergency Cases (Sec. 53.2, RA 9184)

WHEREAS; the DepEd-Kidapawan City Division Bids and Awards Committee conducted a Pre-Procurement Activity on December 2, 2020 for the Supply and Delivery of Supplies for the Reproduction of MHPSS and Self-Learning Modules for Earthquake Affected Learners in Kidapawan City as Part of Education in Emergency in the New Normal Brought about by COVID-19 Pandemic;

WHEREAS; the BAC determined that it is necessary to procure the said project immediately in order for the program holder to implement it to the affected learners;

WHEREAS; the BAC presented the guidelines in the procurement under Negotiated Procurement – Emergency Cases under Section 53.2 of the 2016 Revised Implementing Rules and Regulations;

WHEREAS; Section 53.2 of the Revised IRR set forth the conditions for the use of the said alternative modality in the following instances:

- a. in case of imminent danger to life or property during a state of calamity;
- b. when time is of the essence arising from natural or man-made calamities; or
- c. other causes where immediate action is necessary to prevent damage to or loss of life, property, or to restore vital public services, infrastructure facilities and other public utilities.

WHEREAS; after the presentation and careful deliberation, the BAC agreed that it had met the requirements needed to resort into Negotiated Procurement – Emergency Cases under Section 53.2 of the 2016 Revised Implementing Rules and Regulations;

NOW THEREFORE; all premises considered, ²⁰²⁰⁻¹²⁻¹⁴⁸¹ the Bids and Awards Committee, hereby resolved, to recommend the procurement of the Supply and Delivery of Supplies for the Reproduction of MHPSS and Self-Learning Modules for Earthquake Affected Learners in Kidapawan City as Part of Education in Emergency in the New Normal Brought about by COVID-19 Pandemic under the Negotiated Procurement – Emergency Cases under Section 53.2 of the 2016 Revised Implementing Rules and Regulations;
