General Guidelines

1. The entry shall focus on the influence of Kidapawan City (people, place, history and others that may related to Kidapawan) in photographers' life.

- 2. Only one photo entry will be allowed per participant. Photo collage is not allowed.
- 3. Photographs must be in digital format. Only online entries will be eligible. No print or film submission will be accepted for entry into the Contest. All digital file must be in JPEG or .jpg format. All digital files must be submitted at their highest resolution.

- 4. Digital manipulation is not allowed. Enhancement must be limited only in minor burning, dodging and/ or color correction is acceptable, as is minor cropping. High dynamic range images (HDR) and stitched panoramas are acceptable.
- 5. Photographs that include sculptures, statues, paintings, and other works of art will be accepted as long as they do not constitute copyright infringement or fraud. When photographing the work of others, it must be as an object in its environment and not a full- frame close-up up of another person's art.
- 6. The entry must be the original work of the entrants and must not have been previously published in any photo contest. By entering the contest, entrant represents, acknowledges, and warrant that the submitted photograph is an original work created solely by the entrant, that the photograph does not infringe on the copyrights, trademarks, moral rights, rights of the privacy/ publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph.
- 7. Entry must not contain date stamps, watermarks or any text on the image.
- 8. Participants shall wave the rights of their entry in favor of City Government for general publication, promotional use and other purposes deemed necessary with proper and due acknowledgement and recognition of the entrants.
- 9. The organizer reserves the right to withdraw any awards at any time should the participants violate any of the rules and regulations of the contest or if it deems, in any way, that granting the participants the award will damage the reputation of the institution.

 - 35% b. Originality and Creativity (The work must be original and creative; the videographer must have artistically woven his/ her interpretation on the focus content)
 - c. Technical Quality 10% (Adhere to the technical requirements and contain elements that are creatively and correctly used. (i.e. text, illustrations, etc.)
 - d. FB Reactions (Measures of audience impression on the video. All FB reactions on the official FB account of SK will be counted)



- 2. The entry must be the original work of the entrants and must not have been previously published in any vlog competition.
- 3. Content must not be offensive, threatening, defamatory, libelous, or contain any content that is inappropriate, indecent, profane, discriminatory in any way, or that promotes hatred or harm against any person or group, or otherwise does not comply with the theme and spirit of the contest.
- 4. The entry must be at least 3 minutes and not exceed 10 minutes including the credits. Entries who do not meet the required time will have a corresponding deductions from judges' total score, 0.5 for every second.
- 5. The videos must be in the highest quality possible. Participants may use any appropriate background music or effect.
- 6. Submitted videos must focus on the tourist spots in our City and/ or the things you love about Kidapawan City.
- 7. Entrants shall observe minimum health protocol in doing the vlog.
- 8. Participants shall wave the rights of their entry in favor of City Government for general publication, promotional use and other purposes deemed necessary with proper and due acknowledgement and recognition of the entrants.

- 4. The storyline should be in Filipino, English, or combination of both (Taglish) and must illustrate any one topic for the official entry: Mt. Apo, Obo- Manobo, The White House (Kiram Mansion) or any historic places or event in Kidapwan City,
- 5. Graphics used should be original, licensed or in public domain. The finished entry should be in JPEG and vertical file and should follow the file name format: Comics Title Page Number.jpeg.
- 6. Entries should have a minimum of five pages, inclusive of the front comic title page, and a minimum of 4 frames per page except the comic title page.
- 7. Participants shall wave the rights of their entry in favor of City Government for general publication, promotional use and other purposes deemed necessary with proper and due acknowledgement and recognition of the entrants.
- 8. The organizer reserves the right to withdraw any awards at any time should the participants violate any of the rules and regulations of the contest or if it deems, in any way, that granting the participants the award will damage the reputation of the institution.
