Approving the Award for the CY 2021 BEFF Repair of Classrooms: Luvimin Elementary School

WHEREAS; the DepEd-Kidapawan City Division Bids and Awards Committee declared the procurement process for the CY 2021 BEFF Repair of Classrooms: Luvimin Elementary School;

WHEREAS; the Invitation for the CY 2021 BEFF Repair of Classrooms: Luvimin Elementary School was posted at PHILGEPS on July 2, 2021;

WHEREAS; on July 8, 2021, a Pre-bid conference was conducted and attended by members of the BAC, TWG, Secretariat and prospective bidders. The conference was presided by Dr. Meilrose B. Peralta, OIC-Assistant Schools Division Superintendent, Chairperson of the BAC and that issues and concerns were discussed;

WHEREAS; the opening of bids was conducted on July 22, 2021 at Conference Room, New SDO Kidapawan Building and presided by Dr. Meilrose B. Peralta, OIC-Assistant Schools Division Superintendent, Chairperson of the BAC and that nine (9) bidders dropped their bids: RDEN Construction and Supply, KLD Engineering Construction, ARCKIT Builders and Supply, Everton Gen. Construction and Dev't. Co., Sudapin Construction Supplies and Engineering Services, CLA Construction General Engineering, Megablue Konstrak Corporation, VD Builders and Construction Supplies and Golden A Nine Construction;

WHEREAS; during the opening of Legal and Technical Envelopes, all bidders had complied all the requirements and marked **PASSED**;

WHEREAS; the Financial Envelope was opened and the offer of the bidders are as follow:

Megablue Konstrak Corporation – Php 3,239,558.78
VD Builders and Construction Supplies – Php 2,891,174.07
Golden A Nine Construction – Php 2,831,357.53

WHEREAS; the Technical Working Group conducted bid evaluation and post qualification for the lowest bidder to determine its completeness, authenticity, validity and compliance to technical specifications.

WHEREAS; the result of the Detailed Evaluation of bids and conduct of Post Qualification by the Technical Working Group (TWG) to Everton Gen. Construction and Dev't. Co. had complied and passed the evaluation;

WHEREAS; the bid of Everton Gen. Construction and Dev't. Co. of **Two Million Seven Hundred Eight Thousand Three Hundred Sixty-One & 80/100 Pesos Only (Php 2,708,361.80)** for the CY 2021 BEFF Repair of Classrooms: Luvimin Elementary School is considered to be the Lowest Calculated Responsive Bid;




