Approving the Procurement of the Construction of Water System with Elevated Tank for DepEd Kidapawan City Division Office under Negotiated Procurement - Emergency Cases (Sec. 53.2, RA 9184)

Whereas, on a letter dated June 7, 2021, DepEd-Kidapawan City Division Engineer, Engr. Yousoph T. Lintongan, proposed to the Head of the Procuring Entity (HOPE) the Construction of Water System with Elevated Tank for DepEd Kidapawan City Division Office due to the shortage of water supply from Metro Kidapawan Water District (MKWD) waterline;

Whereas, Engr. Yousoph T. Lintongan also sought the approval of the Head of the Procuring Entity (HOPE) to allow the procurement of the said project through Negotiated Procurement – Emergency Cases under Section 53.2 of the 2016 Revised Implementing Rules and Regulations;

Whereas, the BAC determined that it is necessary to procure the said project immediately because the current water supply is not enough to the cater the needs of the employees in both the old and new buildings;


Whereas, Section 53.2 of the Revised IRR set forth the conditions for the use of the Negotiated Procurement – Emergency Cases under Section 53.2 of the 2016 Revised Implementing Rules and Regulations:

- a. in case of imminent danger to life or property during a state of calamity;
- b. when time is of the essence arising from natural or man-made calamities; or
- c. other causes where immediate action is necessary to prevent damage to or loss of life, property, or to restore vital public services, infrastructure facilities and other public utilities.

Whereas, after careful deliberation, the BAC agreed that it had met the requirements needed to resort into Negotiated Procurement – Emergency Cases under Section 53.2 of the 2016 Revised Implementing Rules and Regulations;
