Approving the Award for the Supply and Delivery of Quarter 1 and Quarter 2 Learning Resources for SY 2021-2022 on the Implementation of Basic Education Learning Continuity Plan (BE-LCP)

WHEREAS; the DepEd-Kidapawan City Division Bids and Awards Committee declared the procurement process for the Supply and Delivery of Quarter 1 and Quarter 2 Learning Resources for SY 2021-2022 on the Implementation of Basic Education Learning Continuity Plan (BE-LCP);

WHEREAS; the Invitation for the Supply and Delivery of Quarter 1 and Quarter 2 Learning Resources for SY 2021-2022 on the Implementation of Basic Education Learning Continuity Plan (BE-LCP) was re-posted at PHILGEPS on November 19, 2021;

WHEREAS; on November 26, 2021, a Pre-bid conference was conducted and attended by members of the BAC, TWG, Secretariat and prospective bidders. The conference was presided by Dr. Ronela S. Molina, OIC-Chief, CIDS, Vice-Chairman of the BAC and that issues and concerns were discussed;

WHEREAS; the opening of bids was conducted on December 9, 2021 at Conference Room, New SDO, Kidapawan Building and presided by Dr. Ronela S. Molina, OIC-Chief, CID, Vice-Chairman of the BAC and that only one (1) bidder dropped its bid: Blue Chips Computer Sales and Services;

WHEREAS; during the opening of Legal and Technical Envelopes, the lone bidder had complied all the requirements and marked **PASSED**;

WHEREAS; the Financial Envelope was opened and the offer of the bidder is as follow:

Blue Chips Computer Sales and Services – Php 1,586,930.00

WHEREAS; the Technical Working Group conducted bid evaluation and post qualification for the lone bidder to determine its completeness, authenticity, validity and compliance to technical specifications.

WHEREAS; the result of the Detailed Evaluation of bids and conduct of Post Qualification by the Technical Working Group (TWG) to Blue Chips Computer Sales and Services had complied and passed the evaluation;

WHEREAS; the bid of Blue Chips Computer Sales and Services of **One Million Five Hundred Eighty-Six Thousand Nine Hundred Thirty Pesos Only (Php 1,586,930.00)** for the Supply and Delivery of Quarter 1 and Quarter 2 Learning Resources for SY 2021-2022 on the Implementation of

Basic Education Learning Continuity Plan (BE-LCP) is considered to be the Single Calculated Responsive Bid;
