WHEREAS; the opening of bids was conducted on December 28, 2021 at Conference Room, New SDO, Kidapawan Building and presided by Dr. Meilrose B. Peralta, OIC-Assistant Schools Division Superintendent, Chairperson of the BAC and that three (3) bidders dropped their bids: Rhoding Food Services, Percheron Marketing and General Merchandise and Leclec's Bakeshoppe & Catering Services;

WHEREAS; Rhoding Food and Services withdrew its bid for the banana chips item due to suddenly increase on the price in the market;

WHEREAS; the bid proposal of Percheron Marketing and General Merchandise and Leclec's Bakeshoppe & Catering Services were found to be substantially complying of bid; \_ 1 2 1 9 1 5
