Approving the Award for the Supply and Delivery of Covid-19 Mitigation Supplies, Clinic Materials and Equipment, School Supplies and Furniture, and Construction Materials in Support for the Limited Face to Face Classes of 27 Schools in Kidapawan City – Lot 2

WHEREAS; the DepEd-Kidapawan City Division Bids and Awards Committee declared the procurement process for the Supply and Delivery of Covid-19 Mitigation Supplies, Clinic Materials and Equipment, School Supplies and Furniture, and Construction Materials in Support for the Limited Face to Face Classes of 27 Schools in Kidapawan City – Lot 2;

WHEREAS; the Invitation for the Supply and Delivery of Covid-19 Mitigation Supplies, Clinic Materials and Equipment, School Supplies and Furniture, and Construction Materials in Support for the Limited Face to Face Classes of 27 Schools in Kidapawan City – Lot 2 was posted at PHILGEPS on February 24, 2022;

WHEREAS; on March 3, 2022, a Pre-bid conference was conducted and attended by members of the BAC, TWG, Secretariat and prospective bidders. The conference was presided by Dr. Meilrose B. Peralta, Assistant Schools Division Superintendent, Chairperson of the BAC and that issues and concerns were discussed;

WHEREAS; the opening of bids was conducted on March 15, 2022 at Conference Room, New SDO Kidapawan Building and presided by Dr. Meilrose B. Peralta, Assistant Schools Division Superintendent, Chairperson of the BAC and that only one (1) bidder dropped its bid: Melanie Drug;

WHEREAS; during the opening of Legal and Technical Envelope, the lone bidder had complied all the requirements and marked PASSED;

WHEREAS; the Financial Envelope was opened and the offer of the bidder is as follow:

Melanie Drug - Php 699,017.00

WHEREAS; the Technical Working Group conducted bid evaluation and post qualification for the lone bidder to determine its completeness, authenticity, validity and compliance to technical specifications.

WHEREAS; the result of the Detailed Evaluation of bids and conduct of Post Qualification by the Technical Working Group (TWG) to Melanie Drug had complied and passed the evaluation;

WHEREAS; the bid of Melanie Drug of Six Hundred Ninety-Nine Thousand Seventeen Pesos Only (Php 699,017.00) for the Supply and Delivery of Covid-19 Mitigation Supplies, Clinic Materials

and Equipment, School Supplies and Furniture, and Construction Materials in Support for the Limited Face to Face Classes of 27 Schools in Kidapawan City – Lot 2 is considered to be the Single Calculated Responsive Bid;

NOW THEREFORE: We the member of Division Bids and Awards Committee (BAC) of the Department of Education, Kidapawan City Division, Kidapawan City hereby **RESOLVED:**

- a. To award the Supply and Delivery of Covid-19 Mitigation Supplies, Clinic Materials and Equipment, School Supplies and Furniture, and Construction Materials in Support for the Limited Face to Face Classes of 27 Schools in Kidapawan City Lot 2 to Melanie Drug in the amount of Six Hundred Ninety-Nine Thousand Seventeen Pesos Only (Php 699,017.00);
- b. To recommend for approval by the Schools Division Superintendent, DepEd Kidapawan City Division, Kidapawan City, and the decision of the Division BAC to enter into contract with **Melanie Drug** for the Supply and Delivery of Covid-19 Mitigation Supplies, Clinic Materials and Equipment, School Supplies and Furniture, and Construction Materials in Support for the Limited Face to Face Classes of 27 Schools in Kidapawan City Lot 2.
