**Approving the Award for the Supply and Delivery of Construction Materials in Support for the Limited Face to Face Classes of 27 Schools in Kidapawan City**

**WHEREAS;** the project for the Supply and Delivery of Construction Materials in Support for the Limited Face to Face Classes of 27 Schools in Kidapawan City incurred two-failed biddings;

**WHEREAS;** the DepEd-Kidapawan City Division Bids and Awards Committee agreed to resort to negotiated procurement pursuant to provisions of Implementing Rules and Regulations of Republic Act 9184;

**WHEREAS;** the BAC through its Secretariat send Request for Quotations to three (3) qualified suppliers: Central Mindanao Construction Multi-Purpose Cooperative, 3M1 Lumber and Construction Supply and DVC Marketing and Services;

**WHEREAS;** the opening of bids was conducted on April 18, 2022 and that only one (1) bidder dropped its bid: Central Mindanao Construction Multi-Purpose Cooperative;

**WHEREAS;** the bid proposal of the bidder was found to be substantially complying of bids;

**WHEREAS;** the Technical Working Group conducted bid evaluation and post qualification for the lone bidder to determine its completeness, authenticity, validity and compliance to technical specifications.

**WHEREAS;** the result of the Detailed Evaluation of bids and conduct of Post Qualification by the Technical Working Group (TWG) to Central Mindanao Construction Multi-Purpose Cooperative had complied and passed the evaluation;

**WHEREAS;** the bid of Central Mindanao Construction Multi-Purpose Cooperative of **Four Hundred Fifty-Nine Thousand Four Hundred Fifty-Eight Pesos Only (Php 459,458.00)** for the **Supply and Delivery of Construction Materials in Support for the Limited Face to Face Classes of 27 Schools in Kidapawan City** is considered to be the Single Calculated Responsive Bid;

**NOW THEREFORE:** We the member of Division Bids and Awards Committee (BAC) of the Department of Education, Kidapawan City Division, Kidapawan City hereby **RESOLVED:**


- a. To award the Supply and Delivery of Construction Materials in Support for the Limited Face to Face Classes of 27 Schools in Kidapawan City to Central Mindanao Construction Multi-Purpose Cooperative in the amount of **Four Hundred Fifty-Nine Thousand Four Hundred Fifty-Eight Pesos Only (Php 459,458.00)**;

- b. To recommend for approval by the Schools Division Superintendent, DepEd Kidapawan City Division, Kidapawan City, and the decision of the Division BAC to enter into contract with **Central Mindanao Construction Multi-Purpose Cooperative** for the Supply and Delivery of Construction Materials in Support for the Limited Face to Face Classes of 27 Schools in Kidapawan City.
