Approving the Award for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program for SY 2021-2022 (Banana Chips)

WHEREAS; the DepEd-Kidapawan City Division Bids and Awards Committee declared the procurement process for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program for SY 2021-2022 (Banana Chips);

WHEREAS; the Bids and Awards Committee recommended for the Request for Quotation-Negotiated mode of procurement after the above-mentioned items incurred two-failed biddings;

WHEREAS; the Bids and Awards Committee sent Request for Quotations to three (3) qualified suppliers: Percheron Marketing and General Merchandise, Rhoding Food Services and Leclec's Bakeshoppe & Catering Services;

WHEREAS; the opening of bids was conducted on January 27, 2022 at Conference Room, New SDO, Kidapawan Building and presided by Dr. Meilrose B. Peralta, OIC-Assistant Schools Division Superintendent, Chairperson of the BAC and that only one (1) bidder dropped its bid: Percheron Marketing and General Merchandise;

WHEREAS; the bid proposal of Percheron Marketing and General Merchandise was found to be substantially complying of bid;
