Approving the Award for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program for SY 2021-2022 (Carrot Muffins, Cheese Bread, Pan De Coco, Cheese Roll, Ube Bread, Banana Cake with Nuts, Calamansi/Carrot Juice, Banana-Lakatan)

WHEREAS; the DepEd-Kidapawan City Division Bids and Awards Committee declared the procurement process for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program for SY 2021-2022;

WHEREAS; the Invitation for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program for SY 2021-2022 was re-posted at PHILGEPS on November 24, 2021;

WHEREAS; on December 2, 2021, a Pre-bid conference was conducted and attended by members of the BAC, TWG, Secretariat and prospective bidders. The conference was presided by Dr. Ronela S. Molina, OIC-Chief, CIDS, Vice-Chairman of the BAC and that issues and concerns were discussed;

WHEREAS; the opening of bids was conducted on December 14, 2021 at Conference Room, New SDO, Kidapawan Building and presided by Dr. Ronela S. Molina, OIC-Chief, CID, Vice-Chairman of the BAC and that three (3) bidders dropped their bids: D Paragon AA Corporation, Enriquez and Coroza Food Corporation & Rhoding Food Services;

WHEREAS; during the opening of Legal and Technical Envelopes, D Paragon AA Corporation was disqualified due to non-compliant of the checklist no. 9, 10 & 11 while Enriquez and Coroza Food Corporation & Rhoding Food Services had complied all the requirements and marked **PASSED**;

WHEREAS; the Financial Envelopes were opened and the offer of the bidders are as follows:

WHEREAS; the bid of Enriquez and Coroza Food Corporation for the items: E-Nutribun, Milky Bun and Ensaymada with mongo fillings of **Two Million Six Hundred Ninety-Three Thousand Nine Hundred Eighty-Five & 66/100 Pesos Only (Php 2,693,985.66)** and Rhoding Food Services for the items: Carrot Muffins, Cheese Bread, Pan De Coco, Cheese Roll, Ube Bread, Banana Cake with Nuts, Calamansi/Carrot Juice and Banana-Lakatan of **Two Million Two Hundred Eighty Thousand Seven Hundred Seventeen Pesos Only (Php 2,280,717.00)** for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program for SY 2021-2022 are considered to be the Lowest Calculated Responsive Bids; 2021-12-18 1:2

To recommend for approval by the OIC-Schools Division Superintendent, DepEd Kidapawan City Division, Kidapawan City, and the decision of the Division BAC to enter into contract with **Enriquez and Coroza Food Corporation** for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program for SY 2021-2022 (E-Nutribun, Milky Bun and Ensaymada with mungo fillings) and **Rhoding Food Services** for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program for SY 2021-2022 (Carrot Muffins, Cheese Bread, Pan De Coco, Cheese Roll, Ube Bread, Banana Cake with Nuts, Calamansi/Carrot Juice, Banana-Lakatan).
