## BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION NO. \_\_01 6 \_\_s. 2022

Approving the Award for the Supply and Delivery of Supplies for the Development, Quality Assurance and Printing of Learning Resources and Purchase of Smart TVs for 21st Century Classroom in Support to the Implementation of Basic Education Learning Recovery and Continuity Plan (BE-LRCP) for 2022-2023 - Lot 3

WHEREAS, the DepEd-Kidapawan City Division Bids and Awards Committee declared the procurement process for the Supply and Delivery of Supplies for the Development, Quality Assurance and Printing of Learning Resources and Purchase of Smart TVs for 21st Century Classroom in Support to the Implementation of Basic Education Learning Recovery and Continuity Plan (BELRCP) for 2022-2023 - Lot 3;

WHEREAS, the Invitation for the Supply and Delivery of Supplies for the Development, Quality Assurance and Printing of Learning Resources and Purchase of Smart TVs for 21st Century Classroom in Support to the Implementation of Basic Education Learning Recovery and Continuity Plan (BE-LRCP) for 2022-2023 - Lot 3 was posted at PHILGEPS on September 24, 2022;

WHEREAS, on October 3, 2022, the Pre-bid conference was conducted and attended by members of the BAC, TWG, Secretariat and prospective bidders. The conference was presided by Dr. Meilrose B. Peralta, Assistant Schools Division Superintendent, BAC Chair and that project procurement details were discussed;

WHEREAS, on the opening of bids which was conducted on October 17, 2022 at the Conference Hall of the Schools Division Office (SDO), there are three (3) bidders dropped their bids: Central Mindanao Construction Multi-Purpose Cooperative (CMCMPC), Copylandia Office Systems 'Corporation and M Dejesica Enterprises;

WHEREAS, during the opening of Legal and Technical Envelopes, the BAC ruled to disqualify Central Mindanao Construction Multi-Purpose Cooperative (CMCMPC) due to the absence of "Flash Drive" as part of the additional documents while Copylandia Office Systems Corporation and M Dejesica Enterprises had complied all the requirements and marked PASSED;

WHEREAS, the Financial Envelopes were opened and the offer of the bidders are as follows:

Copylandia Office Systems Corporation - Php 234,575.00; M Dejesica Enterprises - Php 213,727.70

WHEREAS, the Technical Working Group conducted bid evaluation and post qualification for the lowest bidder to determine its completeness, authenticity, validity and compliance to technical specifications;

WHEREAS, the result of the Detailed Evaluation of bids and conduct of Post Qualification by the Technical Working Group (TWG) to M Dejesica Enterprises had complied and passed the evaluation:

WHEREAS, the bid of M Dejesica Enterprises of Two Hundred Thirteen Thousand Seven Hundred Twenty-Seven & 70/100 Pesos Only (Php 213,727.70) for the Supply and Delivery of Supplies for the Development, Quality Assurance and Printing of Learning Resources and Purchase of Smart TVs for 21st Century Classroom in Support to the Implementation of Basic Education Learning Recovery and Continuity Plan (BE-LRCP) for 2022-2023 - Lot 3 is considered to be the Lowest Calculated Responsive Bid;

NOW THEREFORE, we the members of Division Bids and Awards Committee (BAC) of the Department of Education, Kidapawan City Division, Kidapawan City hereby RESOLVED:

- To award the Supply and Delivery of Supplies for the Development, Quality a.
