**RESOLUTION NO. 011 s. 2022**

**Approving the Award for the Supply and Delivery of Supplies for the Development, Quality Assurance and Printing of Learning Resources and Purchase of Smart TVs for 21st Century Classroom in Support to the Implementation of Basic Education Learning Recovery and Continuity Plan (BE-LRCP) for 2022-2023 - Lot 4**

**WHEREAS**, the DepEd-Kidapawan City Division Bids and Awards Committee declared the procurement process for the Supply and Delivery of Supplies for the Development, Quality Assurance and Printing of Learning Resources and Purchase of Smart TVs for 21st Century Classroom in Support to the Implementation of Basic Education Learning Recovery and Continuity Plan (BE-LRCP) for 2022-2023 - Lot 4;

**WHEREAS**, the Invitation for the Supply and Delivery of Supplies for the Development, Quality Assurance and Printing of Learning Resources and Purchase of Smart TVs for 21st Century Classroom in Support to the Implementation of Basic Education Learning Recovery and Continuity Plan (BE-LRCP) for 2022-2023 - Lot 4 was posted at PHILGEPS on September 24, 2022;

**WHEREAS**, on October 3, 2022, the Pre-bid conference was conducted and attended by members of the BAC, TWG, Secretariat and prospective bidders. The conference was presided by Dr. Meilrose B. Peralta, Assistant Schools Division Superintendent, BAC Chair and that project procurement details were discussed;

**WHEREAS**, on the opening of bids which was conducted on October 17, 2022 at the Conference Hall of the Schools Division Office (SDO), only one (1) bidder dropped their bid: Central Mindanao Construction Multi-Purpose Cooperative (CMCMPC);

**WHEREAS**, during the opening of Legal and Technical Envelopes, the BAC ruled to disqualify Central Mindanao Construction Multi-Purpose Cooperative (CMCMPC) due to the absence of "Flash Drive" as part of the additional documents required to be submitted. Hence, declared a failure of bidding;

**WHEREAS**, the Bids and Awards Committee (BAC) recommended for the reposting of the project and Invitation to Bid in PHILGEPS;

**WHEREAS**, on November 4, 2022, 2<sup>nd</sup> Pre-bid conference was conducted and attended by members of the BAC, TWG and Secretariat. The conference was presided by Dr. Meilrose B. Peralta, Assistant Schools Division Superintendent, BAC Chair and that project procurement details were discussed.

**WHEREAS**, on the opening of bids which was conducted on November 16, 2022 at the Conference Hall of the Schools Division Office (SDO), only one (1) bidder dropped their bid: M Dejesica Enterprises;

**WHEREAS**, during the opening of Legal and Technical Envelopes, the bidder had complied all the requirements and marked PASSED;

**WHEREAS**, the Financial Envelope was opened and the offer of the bidder is Php 215,663.00;

**WHEREAS**, the Technical Working Group conducted bid evaluation and post qualification for the lone bidder to determine its completeness, authenticity, validity and compliance to technical specifications.

**WHEREAS**, the result of the Detailed Evaluation of bids and conduct of Post Qualification by the Technical Working Group (TWG) to M Dejesica Enterprises had complied and passed the evaluation;

**WHEREAS**, the bid of MDejesica Enterprises of **Two Hundred Fifteen Thousand Six Hundred Sixty-Three Pesos Only (Php 215,663.00)** for the **Supply and Delivery of Supplies for the Development, Quality Assurance and Printing of Learning Resources and Purchase of Smart TVs for 21st Century Classroom in Support to the Implementation of Basic Education Learning Recovery and Continuity Plan (BE-LRCP) for 2022-2023 - Lot 4** is considered to be the Single Calculated Responsive Bid;

**NOW THEREFORE**, we the members of Division Bids and Awards Committee (BAC) of the Department of Education, Kidapawan City Division, Kidapawan City hereby **RESOLVED**:

- a. To award the Supply and Delivery of Supplies for the Development, Quality Assurance and Printing of Learning Resources and Purchase of Smart TVs for 21st Century Classroom in Support to the Implementation of Basic Education Learning Recovery and Continuity Plan (BE-LRCP) for 2022-2023 - Lot 4 to **M Dejesica Enterprises** in the amount of **Two Hundred Fifteen Thousand Six Hundred Sixty-Three Pesos Only (Php 215,663.00)**;
- b. To recommend for approval by the Schools Division Superintendent, DepEd Kidapawan City Division, Kidapawan City, and the decision of the Division BAC to enter into contract with **M Dejesica Enterprises** for the Supply and Delivery of Supplies for the Development, Quality Assurance and Printing of Learning Resources and Purchase of Smart TVs for 21st Century Classroom in Support to the Implementation of Basic Education Learning Recovery and Continuity Plan (BE-LRCP) for 2022-2023 - Lot 4.
