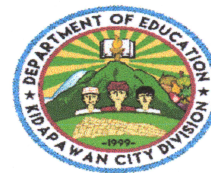

**Whereas**, the detailed evaluation of bid was conducted on November 24, 2022 resulted in the following:

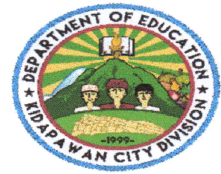




