**RESOLUTION NO. 006 s. 2022**

**Approving the Award for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program FY 2022 (Enriched Nutribun)**

**WHEREAS**, the DepEd-Kidapawan City Division Bids and Awards Committee declared the procurement process for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program FY 2022;

**WHEREAS**, the Invitation for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program FY 2022 was posted at PHILGEPS on July 13, 2022;

**WHEREAS**, on July 21, 2022, the Pre-bid conference was conducted and attended by members of the BAC, TWG, Secretariat and prospective bidders. The conference was presided by Dr. Meilrose B. Peralta, Assistant Schools Division Superintendent, BAC Chair project procurement details were discussed;

**WHEREAS**, on the opening of bids which was conducted on August 2, 2022 at the conference hall of the Schools Division Office (SDO) there were five (5) bidders dropped their bids: Rhoding Food Services, TSM Food Products, Ma-an's Bakeshop, Co., Breadcart Bakeshop & Coffeeshop and Mlang Bread Master;

**WHEREAS**, during the opening of Legal and Technical Envelopes, the BAC ruled to disqualify TSM Food Products due to the absence of "Sanitary Permit" as part of the additional documents required to be submitted while Rhoding Food Services, Ma-an's Bakeshop, Co., Breadcart Bakeshop & Coffeeshop and Mlang Bread Master had complied all the requirements and marked **PASSED**;

**WHEREAS**, the Financial Envelopes were opened and the offer of the bidders are as follows:

**WHEREAS**, the Technical Working Group conducted bid evaluation and post qualification for the lowest bidders per item to determine its completeness, authenticity, validity and compliance to technical specifications;

**WHEREAS**, the result of the Detailed Evaluation of bids and conduct of Post Qualification by the Technical Working Group (TWG) to Breadcart Bakeshop & Coffeeshop and Mlang Bread Master shows that they have failed to established SLCC as per Section 23.4.1.3 of RA 9184. Hence, declared as post-disqualified bidders;

**WHEREAS**, the bid of Rhoding Food Services for the items: Cheese Bread, Star Bread, Carrot Muffin, Choco Bread – Pan de Lanay, Malupandesal, Calamansi Juice and Banana Chips of **One Million Two Hundred Eighty-Six Thousand Nine Hundred Twenty-Seven & 10/100 Pesos Only (Php 1,286,927.10)** and Ma-an’s Bakeshop, Co. for the item: Enriched Nutribun of **Three Hundred Sixty-Seven Thousand Seven Hundred Ninety-One & 30/100 Pesos Only (Php 367,791.30)** for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program FY 2022 are considered to be the Lowest Calculated Responsive Bids;

**NOW THEREFORE**, we the members of Division Bids and Awards Committee (BAC) of the Department of Education, Kidapawan City Division, Kidapawan City hereby **RESOLVED**:

- a. To award the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program FY 2022 (Cheese Bread, Star Bread, Carrot Muffin, Choco Bread – Pan de Lanay, Malupandesal, Calamansi Juice and Banana Chips) to **Rhoding Food Services** in the amount of **One Million Two Hundred Eighty-Six Thousand Nine Hundred Twenty-Seven & 10/100 Pesos Only (Php 1,286,927.10)** and Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program FY 2022 (Enriched Nutribun) to **Ma-an’s Bakeshop, Co.** in the amount of **Three Hundred Sixty-Seven Thousand Seven Hundred Ninety-One & 30/100 Pesos Only (Php 367,791.30)**;
- b. To recommend for approval by the Schools Division Superintendent, DepEd Kidapawan City Division, Kidapawan City, the decision of the Division BAC to enter into contract with **Rhoding Food Services** for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program FY 2022 (Cheese Bread, Star Bread, Carrot Muffin, Choco Bread – Pan de Lanay, Malupandesal, Calamansi Juice and Banana Chips) and **Ma-an’s Bakeshop, Co.** for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program FY 2022 (Enriched Nutribun).
