

Whereas, the Department of Education through Kidapawan City Division is in need of contractor/supplier for the Supply and Delivery of Materials in Support for the Limited Face to Face Classes of 27 Schools in Kidapawan City – Savings from Php 5,313,030.05;

Whereas, on July 1, 2022, the Bids and Awards Committee advertised the Invitation to Apply for Eligibility and to Bid on the **Request for Quotation** for the said project, copy of the Invitation is attached and marked as Annex 1;

Whereas, the opening of bids was conducted on July 6, 2022 and that two (2) suppliers dropped their bids: Titol Aranas Office Supplies and Equipment Trading and M. Dejesica Enterprises;

Whereas, the Bids and Awards Committee (BAC) agreed to disqualify the bid proposal of Titol Aranas Office Supplies and Equipment Trading due to expired Tax Clearance it submitted upon the opening of bids;

Whereas, the bid proposal of M. Dejesica Enterprises was found to be substantially complying of bids;
