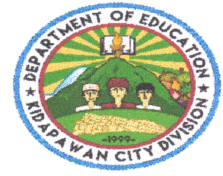

Whereas, the detailed evaluation of bids was conducted on July 7, 2022 resulted in the following:

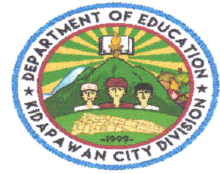
