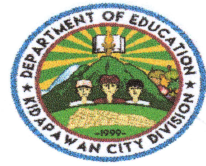

Whereas, the detailed evaluation of bids was conducted on December 20, 2022 resulted in the following:

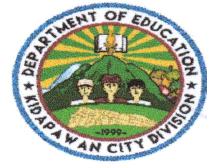
