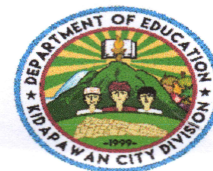

Whereas, the detailed evaluation of bid was conducted on December 26, 2022 resulted in the following:

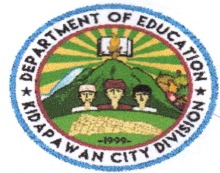


