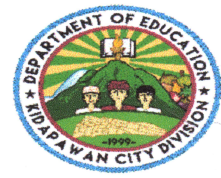

Whereas, the detailed evaluation of bids was conducted on December 26, 2022 resulted in the following:

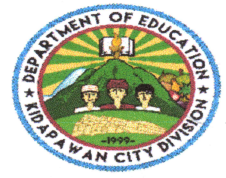
