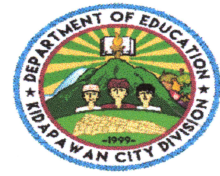

**Whereas**, the Department of Education through Kidapawan City Division is in need of contractor/supplier for the **Supply and Delivery of Instructional Supplies and Materials for ALS Senior High School**;

**Whereas**, on April 14, 2023, the Bids and Awards Committee (BAC) advertised the Invitation to Apply for Eligibility and to Bid on the **Request for Quotation** for the said project, copy of the Invitation is attached and marked as Annex 1;

**Whereas**, the opening of bids was conducted on April 18, 2023 and that three (3) suppliers dropped their bids: Titol Aranas Office Supplies and Equipment Trading, Blue-Chips Computer Sales and Services & Central Mindanao Construction and Multi-Purpose Cooperative;

**Whereas**, the Bids and Awards Committee (BAC) agreed to disqualify the bid proposal of Central Mindanao Construction and Multi-Purpose Cooperative due to the absence of Office Supplies in the line of business of their permit;

**Whereas**, the bid proposals of Titol Aranas Office Supplies and Equipment Trading, Blue-Chips Computer Sales and Services were found to be substantially complying of bids;

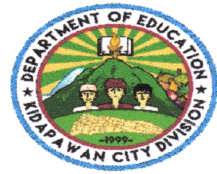
