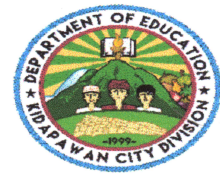

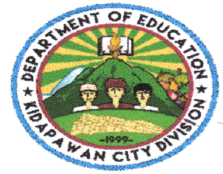
Whereas, the detailed evaluation of bids for the lowest bidder was conducted on April 25, 2023 resulted in the following:
