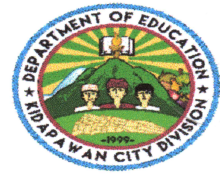

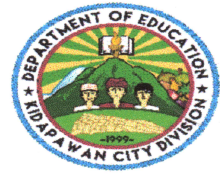
Whereas, the detailed evaluation of bids was conducted on May 05, 2023 resulted in the following:
