Whereas, the opening of bids which was conducted on May 9, 2023 at the conference hall of the Schools Division Office (SDO), there were two (2) bidders dropped their bids: DVC Marketing and Services & Central Mindanao Construction Multi-Purpose Cooperative (CMCMPC);
